



NOTICE OF RACE

2011 Sunfish World Championship in Curaçao

June 12 to 19, 2011

The Organizing Authority is the International Sunfish Class Association,
Laser Performance and the Curaçao Sunfish Sailing Association

0. RESERVATIONS: We recommend making early hotel and flight reservations as soon as possible.

1. RULES

The regatta will be governed by:

- a) The rules as defined in *The Racing Rules of Sailing 2009-2012*, and
- b) The Sunfish Class rules, except as modified by the Charter Agreement.

2. ADVERTISING

This regatta is classified as Category C.

3. ELIGIBILITY AND ENTRY

The regatta shall be limited to sailors qualified per 2010/2011 ISCA & USSCA Notices. Entries shall be limited to 72 competitors.

3.1 Entry Fees:

Registration Fee: US\$300

(This includes the opening ceremony, 4 lunches, BBQ, happy hours, awards dinner and transportation to your hotel)

Non-refundable Charter Fee: US\$425

Damage Deposit: US\$150

3.2 Refunds of Fees:

Entry and charter fees are **NON-REFUNDABLE** unless all 72 spots are filled by the date of the regatta.

All entry fees to be refunded are subject to a 10% administrative fee.

3.3 Participation will be determined as follows:

- all former World Champions;
- the top ten finishers of the 2010 Sunfish World Championship;
- all ISCA officers;
- each NSCA has 5 spots per 20 members; for each additional 10 members, one extra spot is allowed;
- the host country receives 5 extra spots above its normal quota.

3.4 Registration:

Competitors may register by completing the entry form and sending it with the appropriate fees to ISCA, PO Box 300128, Waterford, MI 48330-0128, USA.

Registrations are not considered official until all fees have been received.

Deadline for registration: April 1, 2011.

The Class Office will reserve one (1) entry available to each recognized 2011 NSCA until the registration deadline on April 1, 2011 or until the NSCA registers one (1) or more competitors, whichever occurs first. Immediately after the registration deadline, the Class Office will release all reserved spots that are unused. Only NSCAs with paid 2011 dues by February 28, 2011 will be considered for this reservation, subject to availability.

3.5 Boat Assignment:

Boats that have been used for the Youth World Championship shall be assigned to the same Youth sailors that used them in the Youth World Championship. Boats that were used by Youth sailors who choose not to compete in this Championship will be assigned to the last competitors to register.

3.6 Payment Method:

Payment may be made by credit card, or by check in US dollars payable to "ISCA" drawn on a US bank.

3.7 Checks:

If checks are used, the damage deposit must be sent with a separate check. The damage deposit, whether credit or check, will not be cashed (paid) until the regatta and only in the event of damage.

3.8 Proof of Payment Date:

When paying by check or wire transfer, a scanned copy of the check or wire transfer receipt must be sent by email or fax to the ISCA office to confirm the payment date. For non-US participants, checks must be sent to ISCA by FedEx, DHL or UPS (regular mail is not recommended). The ISCA office will confirm the payment date when the original document is received and the date is compared with the one stamped by the mailing institution. If the document does not arrive within 10 days, the Class Office will ignore the copy of the check and use the real date of reception.

3.9 Other Payment Methods:

In countries where it is not possible to send wire transfers, or use credit cards or checks, competitors will be allowed to reserve spots by sending a letter. However, the funds must be received, by some means, by one ISCA Officer by the registration deadline or the spots will be released. These types of registrations will require the approval of the ISCA President and the ISCA Treasurer.

No more than 3 races per day are planned. The lay day will only be used if fewer than 6 races have been sailed through Wednesday.

5. VENUE

The Caribbean Sea in front of the Lions Dive & Beach Resort, Curaçao

5.1 Measurement:

All boats may be measured against the class rules prior to and/or during the regatta.

5.2 Sailing Instructions:

Will be available at the Registration Desk. Remember to bring your life jacket. Wearing a life jacket during the regatta is required.

6. THE COURSES

The courses to be sailed will be either Windward-Leeward or Triangle or combination thereof. In extraordinary circumstances the Race Committee may decide a different course.

7. PENALTY SYSTEM

Modified Procedures of Appendix P for Rule 42 will be used.

8. SCORING

11 races are scheduled, of which 1 is required to constitute a series.

- a) When fewer than 6 races have been completed, a boat's series score will be the total of her race scores.
- b) When 6 to 11 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

9. PRIZES

Prizes will be given as follows:

Top ten finishers, highest placed female sailor (if the top finisher is male) or the highest placed male sailor (if the top finisher is female), highest placed junior, highest placed master (40+), highest placed grand-master (60+), each race winner (max 11), youngest participant, oldest participant, the Marco Polo prize and the Thomson Trophy for Sportsmanship.

10. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

11. ACCOMMODATION

The official regatta hotel is the **Lions Dive & Beach Resort**, the sportiest hotel in Curaçao (www.lionsdive.com). It has its own private beach, the longest on the island. The Sunfish sailboats will be available and stored on this beach. Transportation between the hotel and beach is not necessary. **Hotel rooms and family apartments are available for a special rate, which cannot be found on the website.** The special rate will not be given to competitors if they contact the hotel directly, the request should go via the local organizers at sunfishworlds2011@gmail.com. If you are interested in receiving more information and hotel conditions, you can email the organization at sunfishworlds2011@gmail.com and we will forward your request to the hotel.

If you are already sure that you will be a participant, it is strongly recommended to make your hotel reservation now.

12. TRANSPORTATION AIRPORT TO HOTEL

After registration, participants may send the organizers an e-mail with flight data so that transportation from the airport to the hotel can be arranged. Please mention date, airline and flight number, and the number of people in your party, including the sailor.
