1. RULES

The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS), the prescriptions of the United States Sailing Association, the International Sunfish Class rules, and the sailing instructions.

2. ELIGIBILITY

This event is open to members of the International Sunfish Class Association who have achieved their 40th birthday by March 13, 2011. Proof of birth date and membership is required. Applications for US Sunfish Class Association will be available at Final Registration/Check-in.

3. ENTRY

Eligible competitors may enter by completing the attached entry form (also available from the FWYC website at www.fwyc.org) and remitting it together with the required fees.

The entry fee will be \$95.00 if postmarked on or before February 25, 2011. Entries postmarked after February 25th and on-site registration will be \$115.00. The fee includes regatta memorabilia, continental breakfast, lunches, and beer/sodas for each race day, dinner on Sunday and Monday nights, and awards. Additional dinners may be purchased at \$10.00 for Sunday dinner and \$15.00 for Monday dinner. Hotdogs will be available to all on Tuesday for \$1.00 each.
