1. ORGANIZING AUTHORITY - The organizing authority is the Gull Lake Yacht Club and the United States Sunfish Class Association.

2. RULES - The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS) and the rules of the International Sunfish Class Association.

3. ENTRY & ELIGIBILITY -

3.1 - The regatta is open to all Sunfish sailboats.

3.2 - All participants must be members of the United States Sunfish Class Association. Competitors must furnish proof of Class membership. Sunfish Class membership applications will be available at registration. If paying by check, a separate check is required for Sunfish Class Membership.

3.3 - All participants shall be 40 years of age or older as of August 6, 2016. Competitors must furnish proof of age.

3.4 - The entry fee is \$95 if postmarked by July 25, 2016, thereafter is \$115, and includes: awards, mementoes, lunch and dinner on Saturday, and breakfast and lunch on Sunday.

3.5 - Please complete the entry form and enclose your check or money order payable to **Connective Marketing**. Mail the form and payment to Connective Marketing, c/o Gail M. Turluck, 1245 West Gull Lake Drive, Richland, MI 49083.

4. MEASUREMENT - The Class Measurer or his representative may measure boats against the Class rules anytime during the regatta.

5. ADVERTISING - Advertising is permitted only in accordance with World Sailing Regulation 20 and the prescriptions of the International Sunfish Class Association.

7. ALTERATIONS TO THE RRS - (this list may not be complete)

7.1 - Race Signal AP will be changed so that, when made ashore, it means; "This race is postponed. The warning signal will be made not less than thirty (30) minutes after AP is lowered."

7.2 - Appendix A4.1 will be changed so that a boat starting later than ten (10) minutes after her starting signal will be scored Did Not Start.

7.3 - RRS 35 and Appendix A4.1 will be changed so that-

a) The time limit will be two (2) hours. Boats failing to finish within thirty (30) minutes after the first boat finishes will be scored Did Not Finish (DNF).

b) When the first boat has not completed the first leg within forty-five (45) minutes after the start, the race will be abandoned.

7.4 - Rule 77 does not apply.

8. SAILING INSTRUCTIONS - Will be available at registration.

9. COURSES –

9.1 - Courses will consist of triangle, windward, leeward, or any combination thereof, using drop marks.

9.2 - The course length will be adjusted to target a race time of 45-50 minutes. A different time to finish will not be considered an improper action or omission of the race committee under rule 61.1(b)

10. RACING AREA – The racing area will be the waters of Gull Lake, Kalamazoo and Barry County, Michigan.

11. SCORING –

11.1 – One (1) race must be completed to constitute a regatta.

11.2 - The Low Point scoring system of Appendix A will apply, modified so that each boat's series score will be the total of her race scores. Six races are scheduled, of which one (1) race is required to be completed to constitute a series. If six races are completed, a yacht may discard its worst score. This changes Appendix A2.

12. SAFETY -

12.1 - Before the first warning signal every day, each boat shall sail past the stern of the race committee signal boat and hail her sail number, which will be acknowledged.

12.2 - A competitor who withdraws from a race or intends not to start a race shall inform the nearest safety or race committee boat as soon as possible. Competitors who leave the racing area before the final finish of the day must check in at the communication table immediately upon return to shore.

13. AWARDS -

13.1 - Age Group Awards –

Prizes will be awarded to the Skipper of the top three skippers in each Division:

-Supreme Master 70+,

-Grand Master 60-69,

-Master 50-59,

-Apprentice Master 40-49.

13.2 - Overall Awards –

There will be an award for the top three finishers in the regatta overall.

13.3 – World Championship Berth -

This regatta qualifies the top overall finisher competitor to attend the 2017 Sunfish World Championship per the 2016 United States Sunfish Class Association Class Notice.

14. BOAT CHARTERS -

16. DIRECTIONS – DO NOT TRUST A GPS—IT WILL GET YOU LOST. THERE IS ROAD CONSTRUCTION, 35TH STREET NORTH OF GALESBURG IS CLOSED. FOLLOW THESE DIRECTIONS! The launch site is at Gull Lake Yacht Club, 9725 West Gull Lake Drive, Richland, Michigan 49083. Take I-94 to the Sprinkle Road exit (exit 80). Go North on Sprinkle Road to Gull Road, turn right. Take Gull Road to Richland; at an angle right it becomes East D Avenue. Go straight a half block to the stop light; turn left onto 32nd Street/M-89/M-43. Go a couple miles to "BC Avenue," turn right. Go approximately 1.5 miles, club on left. Will launch off our NEW ramp by crane or beach toward south end of property.
